| <p><b>Restricted items</b></p> | <ul style="list-style-type: none"> <li>Live animals – health certificate required along with complete and valid inoculations. Contact nearest embassy to obtain permission.</li> <li>Endangered species and any products or parts thereof as outlined by CITES maybe be brought in only with CITES permission.</li> <li>Medication.</li> <li>Local currency - Tunisian Dinar (TND) – cash import available only with permission. | <b>Pets</b>           | <ul style="list-style-type: none"> <li>• Certificate of health from veterinary authorities in the country of departure stating that no contagious diseases of animals occurred at place of origin for 6 weeks before shipment.</li> <li>• Cats and dogs: in addition to above, a rabies vaccination certificate issued between 1 and 6 months prior to arrival is required.</li> <li>• Vaccination record.</li> </ul> | <p>Prohibited: the breeds boerboel, pitbull, rottweiler and tosa; and falcons.</p> <p>Animals subject to examination upon arrival.</p>  |         |
