<p>Removal goods - general</p>	<ul style="list-style-type: none"> ▪ <u>Original</u> change of residence Certificate from local consulate or embassy or city hall. ▪ <u>Original</u> Transfer letter from employer at origin. ▪ <u>Original</u> Employment letter from local employer explaining the client is starting a new contract in Ivory Coast. ▪ Copy of a valid passport. ▪ Ivory Coast Entry visa + entry stamp. ▪ Original valued inventory in French dated and signed by the shipper. With origin and destination address. ▪ Invoice for all electrical items less than 6 months 'old. ▪ Invoices for new items. ▪ Packing list in French. ▪ State of filiation (Etat de filiation) document mentioning the two parents name and date of birth (see form on last page) or valid Individual Tax Identification Number. ▪ Original OBL or Sea Way bill/ AWB. ▪ Residence prove from local police ('Certificat de résidence' délivré par le commissariat de dépendance). ▪ Freight invoice (if OBL not rated). ▪ Cargo tracking note (check www.OIC.CI for details). 	<ul style="list-style-type: none"> ▪ Duty rates on new Household Goods of 30-45% CIF value. Exceptions: Computer 6.5 % CIF. 	<ul style="list-style-type: none"> ▪ All non-diplomatic moves are subject to provide with a Tax identification Number. Your destination agent or customer can get it with the "Documents Required" listed. ▪ Customs taxes when granted free entry by Customs based on documents provided = 1% CIF value + customs tax "T.S" EUR 30. ▪ Local Customs insurance is compulsory for clearance purposes. Rate would vary depending on DA insurance broker from 0.15% to 1% (of C&F value). ▪ All sea shipments must be accompanied by a Cargo Tracking Note. ▪ Non-diplomatic shipments subject to random customs scanner and inspection. Additional fees might then apply from DA.

Motor vehicles	<ul style="list-style-type: none"> ▪ Original registration card. ▪ Rated OBL. ▪ Non-sale certificate. ▪ Change of residence certificate/transfer letter. ▪ Copy of passport. ▪ Car invoice if new. 	<ul style="list-style-type: none"> ▪ Duties approx. 35-45% depending on engine CC and customs assessed value 	<ul style="list-style-type: none"> ▪ Customer can import as many vehicles as he wishes it to his name. ▪ Car automatically transferred to customs car park (called Guichet Unique) by only authorized agent (Cote d'Ivoire Logistique) where customs would complete assessment, payment of duties/taxes, registration through his own appointed agent. ▪ If vehicle >10yr: environmental penalty of EUR 250 + EUR 15/year. ▪ 2 custom offices involved into clearance: high risk of storage fees and demurrage. ▪ On 06 December 2017, the Ivorian Council of Ministers adopted a decree limiting the age of previously owned vehicles imported into Côte d'Ivoire. The age limit for imported previously owned cars is now five (05) years from the date of the vehicle's first registration. This measure, which aims to revitalise the car fleet in Côte d'Ivoire for the sake of health, safety and protection of the environment, came into effect in March 2018.

It takes a fortnight to get it from the local Administration. ▪ Most important is to ensure client gets his local diplomatic card prior to shipment arrival which client can only apply for through his organization once he arrives in Ivory Coast. Usually takes 2-3 weeks to be issued. Then her/his organization can apply for franchise (+2-3 weeks). ▪ 2 custom offices involved into Motor vehicle clearance: high risk of storage fees and

General remarks	<ul style="list-style-type: none"> ▪ Customs clearance procedures are rather complex and above and below documents are compulsory : ▪ Freight Invoice ▪ Export customs entry ▪ Detailed and valued inventory signed. 	<ul style="list-style-type: none"> ▪ All documents shall be provided at least 8 days prior to shipment arrival. ▪ Customs clearance takes in average 8-12 days for air shipments / 12-20 days for sea shipments. 	<ul style="list-style-type: none"> ▪ Failure to provide with any required documents might lead to payment of customs fines and penalties (from EUR 100 to EUR 1000).
