The Additional collector has the authority to condone short visits up to 120 days for availing the TR if the reasons given by the customer are found to be satisfactory. ▪ The TR form is signed by the customer at destination. ▪ The transfer of residence also includes foreign nationals coming to Pakistan for a period of two years or more. ▪ To avail the TR the foreigner needs to show a company letter showing his intended posting to be two or more years along with a valid visa. ▪ Following items are allowed on the payment of duties/taxes and the New Regulatory duty as notified from time to time by the federal government. <ul style="list-style-type: none"> ▪ This list is discounted under the Transfer of residence facility: <ul style="list-style-type: none"> ▪ Television/LCD/LED ▪ Deep freezer

Diplomats removals	<ul style="list-style-type: none"> ▪ Exemption certificate issued by Ministry of Foreign Affairs in Islamabad. ▪ Original or Express BL/ AWB. ▪ Inventory/Packing list. ▪ Authority letter from Mission for customs and Shipping line/ Airline. 	<ul style="list-style-type: none"> ▪ All household goods and personal effects are duty/tax free. ▪ Port storage is free for six days while demurrage for containerized shipments will be charged normally after seven days from vessel arrival. 	<ul style="list-style-type: none"> ▪ The shipment is exempt from any physical checks and does not open at the port/airport. ▪ The MOFA exemptions usually take between two to four weeks to be given. Hence almost all if not all diplomatic shipments incur port / airport storage demurrage and container detention costs. Ask your local partner to best suggest ways to minimize these amounts. ▪ Clearance 2-4 working days. ▪ Customs duties payable in any currency acceptable in Pakistani Banks or in Pak Rupees if the exemption certificate is not available.

Income tax is charged at the assessed value plus the custom duty plus the sales tax value. ▪ Cars older than three years cannot be imported into Pakistan. ▪ A depreciation of 2% /month is calculated from the date of manufacture of the vehicle and is restricted to a maximum of 50%. ▪ Cars/passenger vehicles can be imported under three schemes: <ul style="list-style-type: none"> ▪ Transfer of residence ▪ Gift Scheme ▪ Personal baggage scheme ▪ A diplomat is exempt from all these formalities.
